FLAGGING SYSTEM ANNIVERSARY

This month, 16th February, marked the two year anniversary since the introduction of the Flagging System in targeting prolific offenders through the Retail Crime-watch scheme.

Belfast City Centre Management are delighted to update members that we now have a total of **59** successful convictions for burglary, **30** of which have resulted in a custodial sentence being served. This is a huge milestone for the scheme and, most importantly, our members, in helping to target prolific offenders.

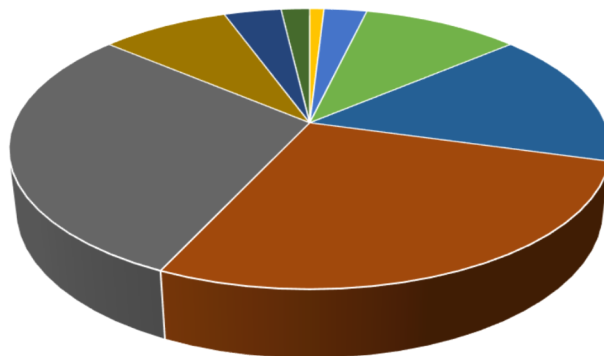

Retail Theft Belfast Area April-Sept 2019



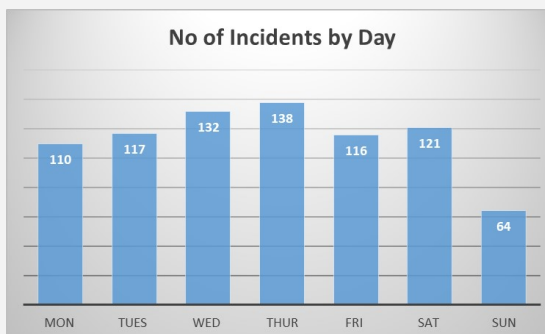

- During this period there was a total of **798** retail theft incidents reported to the PSNI in the Belfast area.
- During this period the most popular time during the week for theft was between **2pm-4pm** followed by **4pm-6pm**.
- During this period the most popular day of the week for theft was Thursday (**138** incidents) followed by Wednesday (**132** incidents)
- During this period there were **153** Exclusion Orders issued by Retail Crime-watch members.

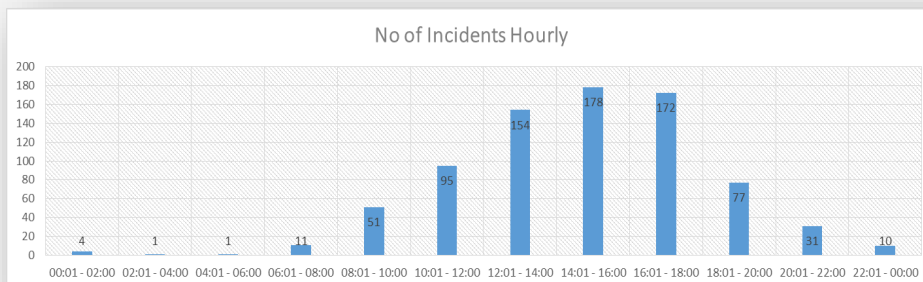
NEW £20 BANKNOTE

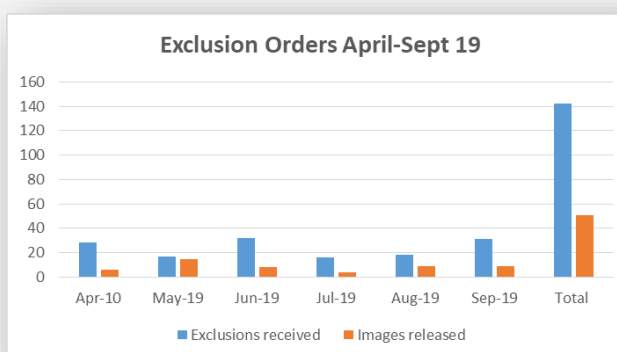
Hourly trends of reported retail theft incidents committed between April and September 2019 reported to the PSNI.

Exclusion Order Analysis

The number of Exclusion Orders issued by Retail Crimewatch members and number of images shared from these issued Exclusion Orders.



- During April to September 2019 there were **153** Exclusion Orders issued resulting in **51** images being shared with Retail Crimewatch members.
- April (**33**) saw the highest number of Exclusions issued followed by June (**32**) and then September (**31**).

During April to September 2019 out of the 153 Exclusion Orders issued by Retail Crime watch members **82** of these offenders were male (54%) and **71** (46%) were female.
